RESOLUTION NO. KL-CY-2017-016

AUTHORIZATION OF CROSS-DEPUTIZATION AGREEMENT ACT OF 2017

At a duly called Session of the Legislature of the Kiowa Tribe held this 10th day of June 2017, the following Resolution and Law were adopted.

WHEREAS; the Legislature is vested with the authority to pass laws and resolutions pursuant to Article VI, Section 6(a) of the Constitution of the Kiowa Tribe; and,

WHEREAS; currently, the Tribe relies on the U.S. Bureau of Indian Affairs Law Enforcement Services ("BIALES") to provide law enforcement services to the Tribe and its members; and,

WHEREAS; the BIALES is underfunded and understaffed leaving the Tribe with inadequate law enforcement services thereby jeopardizing the safety of the Tribe and its citizens.

NOW THEREFORE IT BE IT RESOLVED; that the Legislature hereby enacts the attached law entitled, "AUTHORIZATION OF CROSS-DEPUTIZATION AGREEMENT ACT OF 2017".

Section 1.1 Short Title

This enactment shall be known as, the "AUTHORIZATION OF CROSS-DEPUTIZATION AGREEMENT ACT OF 2017" ("Act").

Section 1.2 Findings.

- (a) Currently, the Tribe relies on the U.S. Bureau of Indian Affairs Law Enforcement Services ("BIALES") to provide law enforcement services to the Tribe and its members;
- (b) The BIALES is underfunded and understaffed leaving the Tribe with inadequate law enforcement services thereby jeopardizing the safety of the Tribe and its citizens;
- (c) The Legislature has determined that it is in the best interests of the Tribe and for the safety of members of the Tribe and others to consider entering into cross-deputization agreements with local law enforcement agencies to assist the BIALES and the Tribe in providing law enforcement services within the Tribe's Territory on an as-needed basis.

Section 1.3 Purpose.

The purpose of this Act is to authorize the Chairman to negotiate and enter into cross deputization agreements with local law enforcement agencies to assist with the provision of law enforcement services within the Tribe's Territory, subject to ratification by the Legislature.

Section 1.4 Authorization for Law Enforcement Cross-Deputization Agreements.

The Legislature hereby authorizes the Chairman to negotiate and execute cross-deputization agreements with local, Oklahoma law enforcement agencies in and around the Tribe's Territory for the purpose of assisting BIALES and the Tribe's Department of Law Enforcement with the provision of law enforcement services within the Tribe's Territory and Jurisdiction; provided, that any cross-deputization agreement executed by the Chairman shall be subject to ratification by the Legislature.
