KIOWA TRIBE RESOLUTION NO. KL-CY-2017-021

COMPENSATION OF EXECUTIVE, LEGISLATIVE, AND JUDICIAL BRANCH OFFICIALS ACT OF 2017

At a duly called Session of the Legislature of the Kiowa Tribe held this 9th day of September 2017, the following Resolution and Law were adopted.

WHEREAS; the Legislature is vested with the authority to pass laws and resolutions pursuant to Article VI, Section 6(a) of the Constitution of the Kiowa Tribe; and,

WHEREAS; the Constitution calls for the compensation of the Chairman, Vice-Chairman, Legislators, and Judges and Justices to be set by law.

NOW THEREFORE BE IT RESOLVED; that the Legislature hereby enacts the attached law entitled, "COMPENSATION OF EXECUTIVE, LEGISLATIVE, AND JUDICIAL BRANCH OFFICIALS ACT OF 2017".

Section 1.1 Short Title

This enactment shall be known as, the "COMPENSATION OF EXECUTIVE, LEGISLATIVE, AND JUDICIAL BRANCH OFFICIALS ACT OF 2017" ("Act").

Section 1.2 Purpose.

The purpose of this Act is to authorize reasonable compensation for officials of the three branches of government.

Section 1.3 Findings.

- (a) The Chairman has requested the Legislature to enact a law to set the salaries of Legislators according to the terms of the new, 2017 Constitution ("Constitution").
- (b) The Constitution calls for the officials of the Executive, Legislative, and Judicial branches of government to be paid reasonable compensation set by law.
- (c) In the Executive branch of government, the Chairman has different duties and responsibilities not shared by the Vice-Chairman, which should be reflected in their salaries.
- (d) In the Legislative branch of government, the Speaker of the Legislature and the Secretary of the Legislature have additional duties and responsibilities not shared by other Legislators, which should be reflected in their salaries.
- (e) In the Judicial branch of government, the Judges of the Trial Court and the Justices of the Supreme Court have different duties and responsibilities, which should be reflected in their compensation.

Section 1.4 Compensation for Officials of Each Branch of Government.

(a) The compensation for the officials of the branches of government shall be authorized as follows:

Chairman Vice-Chairman	<u>Annual Compensation</u> \$67,500 \$57,500
Legislative Branch Officials Speaker of the Legislature Secretary of the Legislature Legislators	<u>Annual Compensation</u> \$47,500 \$47,500 \$45,000
Judicial Branch Officials Interim Chief Judge " "	Compensation \$500 per day (Non-Court appearances) \$1,000 per day (Court Appearances)

\$500 per day

(b) After the June 2018 General Election, the compensation for the officials of the Executive and Legislative branches of government as listed in subsection (a) shall increase by ten percent.
