### KIOWA TRIBE RESOLUTION NO. KL-CY-2018-010

### FIRST AMENDMENT OF THE FIRST ELECTION LAW OF 2018

At a duly called Session of the Legislature of the Kiowa Tribe held this 10th day of March 2018, the following Resolution and Law were adopted.

WHEREAS; the Legislature is vested with the authority to pass laws and resolutions pursuant to Article VI, Section 6(a) of the Constitution of the Kiowa Tribe; and,

**WHEREAS**; prior to the final approval of the Tribe's new Constitution by the BIA, the Business Committee enacted the First Election Law of 2017 to govern the implementation of the new Constitution and the First Election, which is designed to establish staggered terms of office for elected officials in both the June 2017 election and the June 2018 elections; and,

WHEREAS; the Legislature has determined that it is in the best interest of the Tribe to reaffirm the First Election Law of 2017, and to make a minor amendment to clearly apply the requirement to mail ballots to all eligible voters in Districts 1, 3, and 4 in the upcoming June 2018 election cycle.

**NOW THEREFORE BE IT RESOLVED;** that the Legislature hereby enacts the attached law entitled, "FIRST AMENDMENT OF THE FIRST ELECTION LAW OF 2017".

### **Section 1.1** Short Title

This enactment shall be known as the "FIRST AMENDMENT OF THE FIRST ELECTION LAW OF 2017" ("First Amendment").

### Section 1.2 Purpose

The purpose of the First Amendment is to reaffirm the First Election Law of 2017, and to clarify the requirement for the Election Commission to mail ballots to all eligible voters in Districts 1, 3, and 4 in the June 2018 election cycle.

### Section 1.3 Findings

The Legislature finds that:

- (a) Prior to the final approval of the Tribe's new Constitution by the BIA, the Business Committee enacted the First Election Law of 2017 to govern the implementation of the new Constitution and the First Election, which is designed to establish staggered terms of office for elected officials in both the June 2017 election and the June 2018 elections; and,
- (b) The Legislature has determined that it is in the best interest of the Tribe to reaffirm the First Election Law of 2017, and to make a minor amendment to clearly apply the requirement to mail ballots to all eligible voters in Districts 1, 3, and 4 in the upcoming June 2018 election cycle.

### **Section 1.4** Reaffirmation

The Legislature hereby reaffirms and enacts the First Election Law of 2017, as amended.

### Section 1.5 Amendments

- (a) Section 1.9(a) of the First Election Law of 2017 shall be amended by deleting "2, 5, 6, and 7" and replacing it with "1, 3, and 4."
- (b) A new Section 1.11 shall be added to the First Election Law of 2017 as follows:
  - "Section 1.11. <u>Candidate Registration Deadline</u>. A candidate for elective office shall meet all the qualifications for office at the time of filing for candidacy. Once the candidate registration period has closed, no person shall be permitted to make any adjustments, additions, or modifications to their application, documents, or other information submitted by the candidate to the Election Commission, including any steps taken to become eligible or to qualify for elective office after the candidate registration deadline."
