Section 1.1 Short Title

This enactment shall be known as the "ANNUAL BUDGET APPROPRIATION FOR FISCAL YEAR 2018-2019".

Section 1.2 Purpose

The purpose of this Act is to approve an Annual Budget for the Tribe, subject to final approval by the voters.

Section 1.3 Findings

The Legislature hereby finds and declares that:

- (a) On April 17, 2017, the voters of the Tribe approved a new constitution ("Constitution") in a "landslide" vote by 68%;
- (b) The Constitution gives the voters of the Tribe the final decision on the revenue and expenditures of the Tribe by requiring an Annual Budget to be approved by the Legislature by law ("Annual Budget"), subject to final approval of the voters;
- (c) The Annual Budget must include an appropriation of operating funds for the government including the Kiowa Indian Council, the Legislature, the Executive Branch, and the Judicial Branch.
- (d) The Constitution establishes the first step in the Annual Budget process by requiring the Chairman to propose an Annual Budget to the Legislature by February 1st; however, on January 31, 2018, the Chairman's office notified the Legislature that he would be "late", and the Legislature received the Chairman's proposed Annual Budget twenty-eight (28) days after the deadline;
- (e) On March 12, 2018, the Legislature held a budget hearing and formally invited the Chairman's key personnel, including the Finance Director, the Treasurer, and the Administrator, to discuss the Chairman's proposed Annual Budget with the Legislature; however, no one from the Chairman's office appeared at the designated time.
- (f) The Legislature will proceed with the development of an Annual Budget for the Tribe that includes all revenue and the appropriation of funds for expenditure as required by the Constitution, subject to final approval of the voters.

Section 1.4 Approval of Annual Budget for Fiscal Year 2017-2018

The Legislature hereby enacts the attached Annual Budget for Fiscal Year 2018-2019, subject to final approval by the voters.
