RESOLUTION NO. KL-CY-2019-011

DESIGNATION OF TRIBAL HOUSING AUTHORITY

At a duly called Session of the Legislature of the Kiowa Tribe held on the 11th day of May, 2019, the following Resolution and Law were adopted.

WHEREAS, the Legislature is vested with the authority to pass laws and resolutions pursuant to Article VI, Section 6, (a) of the Constitution of the Kiowa Tribe; and,

WHEREAS, the United States Department of Housing and Urban Development requires the Kiowa Tribe to take official action if it chooses to designate a Tribally Designated Housing Entity to be the recipient of the Indian Housing Block Grant funds on behalf of the Kiowa Tribe;

WHEREAS, the Kiowa Tribe has established the (TDHE) Kiowa Tribe Housing Authority and Kiowa Tribe Housing Act, 2019, through appropriate laws and their Constitution; and,

NOW THEREFORE BE IT RESOLVED that the Legislature of the Kiowa Tribe hereby designates the KIOWA TRIBE HOUSING AUTHORITY as the designated housing entity (TDHE) for the Kiowa Tribe and approve Kiowa Tribe Housing Act of 2019.
