KIOWA TRIBE RESOLUTION NO. KL-CY-2019-004

ROAD INVENTORY AND REPAIR PRIORITY ACT OF 2019

At a duly called Session of the Legislature of the Kiowa Tribe held this 9th day of March, 2019, the following Resolution and Law were adopted.

WHEREAS; the Legislature is vested with the authority to pass laws and resolutions pursuant to Article VI, Section 6(a) of the Constitution of the Kiowa Tribe; and,

WHEREAS; the Legislature supports the efforts of the Tribe's Transportation Department to seek funds for road repairs and related matters that benefit Members of the Tribe; and,

WHEREAS; the Legislature has determined that it is in the best interests of the Tribe to set a priority list of roads to be included as high priorities for road maintenance and repair and related matters.

NOW THEREFORE IT BE IT RESOLVED; that the Legislature hereby enacts the attached law entitled, "Road Inventory and Repair Priority Act of 2019".

Section 1.1 Short Title

This enactment shall be known as the "Road Inventory and Repair Priority Act of 2019" ("Act").

Section 1.2 Purpose

The purpose of this Act is to establish a priority list for road maintenance and repairs.

Section 1.3 Findings

- (a). The Legislature supports the efforts of the Tribe's Transportation Department to seek funds for road maintenance and repairs and related matters that benefit Members of the Tribe;
- (b). The Legislature has determined that it is in the best interests of the Tribe to set a priority list of roads and streets to be included as high priorities for road maintenance and repair;
- (c). The Legislature has determined that a street in Anadarko, Oklahoma, called "Davis Street", that serves a number of Members of the Tribe, is a safety hazard and in dire need of maintenance and repair.

Section 1.4 Road Inventory and Priorities

- (a). The Transportation Department shall include the following roads and streets on the IRR list of roads, and shall take all steps necessary to prioritize the maintenance and repair of such roads and streets:
 - 1. "David Street" in Anadarko, Oklahoma
 - 2. Veterans Highway Southeast of Carnegie, Oklahoma: Road begins at CS2485 & CR1340 Markers & Extends South for 1.5 miles to CR1350 & CS2485 Markers and West to CR1350 to CS2480. The Emhoolah, The Toppah, The Yeahquo and Tofpi and Tsonetekoy Families have homesites along this road.
