KIOWA TRIBAL LEGISLATURE PIPELINE EASEMENT LITIGATION AGREEMENT RESOLUTION: KL-CY-2021-0003

A RESOLUTION DULY PROPOSED TO THE KIOWA LEGISLATURE FOR APPROVAL OF CONTRACTING OF A LAW FIRM TO FILE AND TO PROSECUTE CLAIMS ON BEHALF OF THE KIOWA TRIBE AGAINST THE OWNERS OF PIPELINES THAT ARE CROSSING TRIBAL LANDS WITHOUT APPROVED LEASES OR OTHER AGREEMENTS AUTHORIZING THEIR USE OF TRIBAL LANDS.

whereas, the Kiowa Legislature is the lawmaking body of the government of the Kiowa Tribe and has a constitutional duty and authority to approve contracts by law

on behalf of the Kiowa government; and

whereas, the Kiowa Legislature has determined there is one or more continuing trespasses bypipeline owners who are transporting oil, gas, or other valuable products across tribal lands without the required leases or agreements permitting them to use tribal lands for those purposes; and

whereas, the nature of the engagement of law firms to handle these matters are based on contingency fees and will require no appropriation or expenditure of tribal funds, nor the amendment of the approved annual budget; and

WHEREAS, the Legislature authorizes the engagement of The Whitten Burrage Law Firm, and its affiliated attorneys and law firms to prosecute these claims on behalf of the Kiowa Tribe; and

NOW THEREFORE BE IT RESOLVED that the Kiowa Legislature hereby authorizes and approves the execution of the Legal Services Agreement engaging The Whitten Burrage Law Firm to timely make claims, file suit and to represent the Kiowa Tribe under the terms and conditions delineated in the negotiated Agreement.
