RESOLUTION – KL-CY-2021-0009 2021 REVISED ELECTION COMMISSION ORDINANCE

At a duly called meeting of the Legislature of the Kiowa Tribe on this 14th day of August 2021, the following Resolution and law were adopted.

- WHEREAS; The Legislature is vested with the authority to pass laws and resolutions pursuant to Article VI, Section 6(a) of the Constitution of the Kiowa Tribe; and,
- WHEREAS; the Legislature finds the need to update and revise the Ordinance of the Kiowa Election Commission to address changes necessary to enhance the electoral processes of the Kiowa Tribe;
- WHEREAS; The Kiowa Tribe possesses inherent sovereign powers of government by virtue of territorial integrity and democracy. The Constitution of the Tribe shall be the supreme law of the land. All existing laws of the Tribe shall remain in force and effect unless laws are contrary to the terms of this Constitution;
- **WHEREAS**; Revisions to the Ordinance will continue until the document is complete and comprehensive. The Election Ordinance will continue to be a work in progress.

NOW THEREFORE IT BE IT RESOLVED; that the Legislature hereby enacts the attached law entitled, "REVISED ELECTION COMMISSION ORDINANCE".
