## A RESOLUTION OF THE KIOWA TRIBE LEGISLATURE RESOLUTION #KL-CY-2022-008

A resolution of the Kiowa Tribe Legislature, directing Kiowa Tribe Elected Officials, Lawrence Spottedbird, Chairman and Jacob Tsotigh, Vice-Chairman establish and added to any and all established bank accounts for the Kiowa Tribe, at The Farmers Bank, Carnegie, Oklahoma. The accounts will require two (2) signature authorizations from elected officials, Lawrence Spottedbird, Chairman and Jacob Tsotigh, Vice-Chairman, with “inquiry authorization” for any and all accounts established at The Farmers Bank. Additionally, Kiowa Tribe Treasurer and Finance Officer, will also have “inquiry authorization only”. The Kiowa Tribe Legislature, also authorizes The Farmers Bank to delete the following names from the signature cards and inquiry authority: Matthew M. Komalty, Rhonda Ahhaitty, Ernest Redbird, Sr., and Josie Morris.

**WHEREAS**, the Kiowa Tribe of Oklahoma is a sovereign nation since time immemorial and is federally recognized as a Tribal Government by the United States, and,

**WHEREAS**, the Kiowa Tribe Legislature is vested with authority to pass laws and resolutions pursuant to Article VI, Section 6(a) of the Constitution of the Kiowa Tribe; and,

**WHEREAS**, The Kiowa Tribe Legislature is directing Lawrence Spottedbird, Chairman; Jacob Tsotigh, Vice-Chairman to be added as signers and have inquiry authorization to any and all accounts established at The Farmers Bank, Carnegie, Oklahoma. The Treasurer and Finance Officer will have inquiry authorization only, on established any and all checking accounts; and,

**NOW, THEREFORE BE IT RESOLVED**, the Kiowa Tribe Legislature, hereby authorizes, Lawrence Spottedbird, Chairman and Jacob Tsotigh, Vice-Chairman; to establish checking accounts for the Kiowa Tribe of Oklahoma at The Farmers Bank, Carnegie, Oklahoma.




**CERTIFICATION**
