# A RESOLUTION OF THE KIOWA TRIBE LEGISLATURE RESOLUTION #KL-CY-2022-017

A resolution of the Kiowa Tribe Legislature, directing Kiowa Tribe Elected Officials, Lawrence Spottedbird, Chairman and Jacob Tsotigh, Vice-Chairman establish and added to any and all established bank accounts for the Kiowa Tribe, at The Community Bank of Oklahoma, Verden, Oklahoma. The accounts will require two (2) signature authorizations from elected officials, Lawrence Spottedbird, Chairman and Jacob Tsotigh, Vice-Chairman, with "inquiry authorization" for any and all accounts established at The Community Bank of Oklahoma. Additionally, Kiowa Tribe Treasurer and Finance Officer, will also have "inquiry authorization only". The Kiowa Tribe Legislature, also authorizes The Community Bank of Oklahoma to delete the following names from the signature cards and inquiry authority: Matthew M. Komalty, Rhonda Ahhaitty, Ernest Redbird, Sr., and Josie Morris.

**WHEREAS**, the Kiowa Tribe is a sovereign nation since time immemorial and is federally recognized as a Tribal Government by the United States, and,

WHEREAS, the Kiowa Tribe Legislature is vested with authority to pass laws and resolutions pursuant to Article VI, Section 6(a) of the Constitution of the Kiowa Tribe; and,

WHEREAS, The Kiowa Tribe Legislature is directing Lawrence Spottedbird, Chairman; Jacob Tsotigh, Vice-Chairman to be added as signers and have inquiry authorization to any and all accounts established at The Community Bank of Oklahoma, Verden, Oklahoma. The Treasurer and Finance Officer will have inquiry authorization only, on established any and all checking accounts; and,

NOW, THEREFORE BE IT RESOLVED, the Kiowa Tribe Legislature, hereby authorizes, Lawrence Spottedbird, Chairman and Jacob Tsotigh, Vice-Chairman; to establish checking accounts for the Kiowa Tribe at The Community Bank of Oklahoma, Verden, Oklahoma.

**NOW, BE IT FURTHER RESOLVED,** that the Kiowa Tribe Legislature, hereby authorizes Lawrence Spottedbird, Chairman and Jacob Tsotigh, Vice-Chairman of the Kiowa Tribe as the two (2) signatures authorities, for any/all established accounts with "inquiry authorization". Additionally, the Kiowa Tribe Treasurer and Finance Officer, will also have "inquiry authorization only".

**BE IT FINALLY RESOLVED,** that the Kiowa Tribe Legislature authorizes The Community Bank of Oklahoma to delete the following names from the bank signature cards and inquiry authorization: Matthew M. Komalty, Rhonda Ahhaitty, Ernest Redbird, Sr., and Josie Morris.

### CERTIFICATION
