LEGISLATIVE RESOLUTION KL-CY-2023-010

RESOLUTION IN AND FOR THE KIOWA TRIBE FOR THE ESTABLISHMENT AND OPERATION OF THE KIOWA TRIBE DISTRICT CHILDREN'S COURT:

At a duly called Legislative Regular Session LXXII-(72) of the Legislature of the Kiowa Tribe held this 4th day of April, 2023, the following Order, was adopted.

WHEREAS, The Kiowa Tribe of Oklahoma is a federally recognized Indian Tribe with a Constitution approved by the Secretary of the Interior, and

WHEREAS, The Kiowa Legislature is authorized under the Kiowa Constitution and is empowered to promulgate and enforce codes and laws to protect our children who reside on Kiowa trust property and case transferred to it, and

WHEREAS, The Federal Indian Child Welfare Act, 25 U.S.C. ss 1903(12) "Tribal Court" Provides Tribes the right to entertain CFR Courts, a court operated by a Children's Code or administrative body of a tribe vested with authority over child custody proceedings, and

WHEREAS, The Kiowa Tribe has created a Kiowa Tribe District Children's Court for the jurisprudence of Kiowa Youth who may be in a civil or juvenile court setting.

THEREFORE BE IT RESOLVED, the Kiowa Legislature, having been delegated certain authorities under the Kiowa Constitution, the governing body of the Kiowa Tribe, does hereby, by resolution, create a Juvenile Division and proclaim that the Kiowa Tribal District Children's Court be authorized; and by their hand affix their signatures to finalize this entity, as part of the Kiowa Tribe Judicial branch for children.

CERTIFICATION

The foregoing Resolution KL-CY-2023-0010 was duly voted upon by the Legislature on April 04, 2023, at a Legislative Regular Session LXXII-(72), with a vote of (7) in favor and (0) opposed, (0) abstaining, and (0) absent, according to the authority vested in the Legislature by the Constitution of the Kiowa Tribe.
