**Resolution Number: KL-CY-2024-020**

**THE KIOWA TRIBE AUTHORIZED SIGNATORIES TO CONDUCT BUSINESS WITH THE BUREAU OF TRUST FUNDS ADMINISTRATION FOR AMERICAN INDIANS (BTFA).**

At a duly called Legislative Regular Session XCII-(92) of the Legislature of the Kiowa Tribe held this 14th day of December, 2024, the following resolution, was adopted.

**WHEREAS**, the Kiowa Tribe (the “Tribe”) is organized under a constitution, duly adopted and approved by the voters of the Tribe on April 17, 2017 and approved by the U.S. Secretary of the Interior (“Secretary”)(the “Constitution”); and,

**WHEREAS**, the Legislature, is vested with the authority to pass laws and resolutions pursuant to Article VI, Section 6 (a) of the Constitution of the Kiowa Tribe; and,

**WHEREAS**, the Kiowa Constitution, Article VI- Legislative Branch, Section 6. Powers, establishes the Kiowa Tribe Legislature as the duly elected official body designated to conduct business for and on behalf of the Kiowa Tribe, in a legal quorum; and,

**WHEREAS**, the Bureau of Trust Funds Administration for American Indians requires a resolution authorizing tribal officials to conduct business with the Bureau of Trust Funds Administration for American Indians;

**NOW, THEREFORE BE IT RESOLVED**, the Kiowa Tribe Legislature, hereby designates the following authorized signatories:
