A RESOLUTION OF THE KIOWA TRIBE LEGISLATURE RESOLUTION #KL-CY-2025-002

A resolution of the Kiowa Tribe Legislature, directing Kiowa Tribe Officials, Lawrence Spottedbird, Chairman, and William Weaver, Chief Financial Officer, to be added to any and all bank accounts established for the Kiowa Tribe at The Cross First Bank of Tulsa, Tulsa, Oklahoma. Same resolution shall also recognize the authority of Chairman Spottedbird and Chief Financial Officer Weaver to create accounts at The Cross First Bank of Tulsa, Tulsa, Oklahoma. All accounts there established will require two (2) signature authorizations from Tribe officials Lawrence Spottedbird, Chairman, and William Weaver, Chief Financial Officer, and carry "inquiry authorization" for same officials. Additionally, Summer Palmer, Deputy CFO and Violet Kay Langley (Brown), General Ledger Accountant shall have "inquiry authorization only." The Kiowa Tribe Legislature also authorizes The Cross First Bank of Tulsa to delete the following names from the signature cards and inquiry authority: Matthew M. Komalty, Rhonda Jean Ahhaitty, Ernest Redbird, Sr., George Carter, and Josie Morris.

WHEREAS, the Kiowa Tribe is a sovereign nation since time immemorial; and,

WHEREAS, the Tribe has the right to full enjoyment of the inherent powers of government, including self-determination and autonomy over internal affairs; and

WHEREAS, the Kiowa Tribe Legislature is vested with authority to pass laws and resolutions pursuant to Article VI, Section 6(a) of the Constitution of the Kiowa Tribe; and,

WHEREAS, The Kiowa Tribe Legislature is directing Lawrence Spottedbird, Chairman, and William Weaver, Chief Financial Officer, to be added as signers and to have inquiry authorization vis-à-vis any and all accounts established at The Cross First Bank of Tulsa, Tulsa, Oklahoma; and,

WHEREAS, The Treasurer and Finance Officer shall have inquiry authorization only on any and all Kiowa Tribe checking accounts at The Cross First Bank of Tulsa, Tulsa, Oklahoma;

NOW, THEREFORE BE IT RESOLVED, the Kiowa Tribe Legislature, hereby authorizes Lawrence Spottedbird, Chairman, and William Weaver, Chief Financial Officer, to establish checking accounts for the Kiowa Tribe at The Cross First Bank of Tulsa, Tulsa, Oklahoma.

NOW, BE IT FURTHER RESOLVED, that the Kiowa Tribe Legislature, hereby authorizes Lawrence Spottedbird, Chairman of the Kiowa Tribe, and William Weaver, Chief Financial Officer of the Kiowa Tribe, to act as the two (2) signature authorities for any and all

established accounts with "inquiry authorization". Additionally, , Summer Palmer, Deputy CFO and Violet Kay Langley (Brown), General Ledger Accountant will also have "inquiry authorization only".

BE IT FINALLY RESOLVED, that the Kiowa Tribe Legislature authorizes The Cross First Bank of Tulsa to delete the following names from the bank signature cards and inquiry authorization: Matthew M. Komalty, Rhonda Jean Ahhaitty, Ernest Redbird, Sr., George Carter, and Josie Morris.

CERTIFICATION

The foregoing resolution KL-CY-2025-002, was duly voted upon by the Legislature on February 08, 2025, at a Legislative Regular Session XCIV (94) with a vote of (7) in favor and (0) opposed, (0) abstaining, and (0) absent, pursuant to the authority vested in the Legislature by the Constitution of the Kiowa Tribe.
